**Historical Note:** Daniel B. Danielson was one of Milwaukee's most prominent general contractors of the early twentieth century. He was born on February 14, 1873, in Chicago, Illinois. His parents, Bernard J. and Caroline Danielson, emigrated from Norway in 1872 and settled in Chicago. Bernard worked as a carpenter contractor for two years before transplanting his business to Milwaukee. After Daniel finished his schooling, he learned the carpenter's trade from his father and worked as a journeyman carpenter for ten years. In 1900, Daniel launched his own general contracting business, and he quickly became one of the city's more notable individuals in that line of work. He oversaw the construction of several prominent Milwaukee structures, such as the Gustave Pabst residence, the Milwaukee Journal building, Salzmann Library at the St. Francis Seminary, the stock judging pavilion at State Fair Park, and Grace Presbyterian Church. He also patented several innovations, including a "musculous" system of beamless concrete construction. In 1931, he changed the name of the business to the Tie-To-Insert Company. He died on January 11, 1935.

After Daniel's death, his wife, Florence, continued managing the business until her death in 1954. Their daughter, Rayline Oestreich, then assumed control and managed the company until its assets were sold to the Racine Iron & Wire Works, Inc., in 1968.

**Scope and Content:** The bulk of the material consists of correspondence, receipts/invoices, payroll records, estimates, expense statements, building permits and scattered blueprints/diagrams. The first section of the records details the operations of Daniel Danielson's contracting business and includes information on business practices, labor relations and the home front during World War I. It contains general/miscellaneous files as well as records that are arranged by project and/or client [Note: if a document dealt with multiple projects or if a specific project for a document could not be determined, it was included in the general/miscellaneous files]. The second section contains personal records, and the final section consists of business records of the Tie-To-Insert Company. Correspondence files are arranged in reverse chronological order, while receipts/invoices files are arranged alphabetically by the name of the business.
