Abstract: Herbert Schultz was a dedicated public servant throughout his life. He was a soldier in World War I and then an award-winning salesman while preparing for a law career. Schultz was elected as a Milwaukee County Civil Court judge for four, six-year terms, starting in 1942. He presided in several other courts, brought about improvements in the court system, and was appointed to the positions of Magistrate and Court Commissioner, retiring in his eighties. Herbert was active in various community organizations, a member of the Gideon International and was supported by his wife Aurelia, and their children Ralph and Gwen.

Scope and Content: The collection is mainly comprised of court-related material such as case studies, jury instructions, law books, and legal notes, as well as notes, receipts, correspondence and political advertisements relating to the 1942 and 1953 5th District Court campaigns. In addition, there are several folders containing personal correspondence, certificates and awards, sermons, personal memorabilia, a biography of Herbert Schultz, and a history of the Schultz family.
