**Historical Note:** The Fred Gettelman Co., 4400 State Street, was organized November 26, 1929, “to engage in the sale of snow plows and other corporate purposes.” Fred Gettelman began working as the secretary of the A. Gettelman Brewing Company. He later began the president and treasurer. The Fred Gettelman Co. was dissolved April 5, 1957.
