Rules & Contestant Application

Test your meatball recipe against others throughout Milwaukee! The Milwaukee County Historical Society is proud and excited to host the first annual, Milwaukee Meatball Challenge! Prepare for your recipes to be judged by the best chefs and culinary experts in the city.

When: Saturday, March 24, 2012

**Time:** 12:00 p.m.-4:00 p.m. (Winners announced at 4:00 p.m.)

**Where:** Milwaukee County Historical Society @ Historical Center 910 N. Old World 3<sup>rd</sup> Street – Milwaukee, WI 53202

Cost: Admission: \$8.00 +4 food tickets. (Each ticket is good for one meatball serving)

\$2 for each additional food ticket thereafter.

MCHS members are allowed FREE admission +4 food tickets

Contestant entry is FREE. Each contestant is required to purchase Temporary Food Dealer

License for the Challenge at their own cost.

Food: Contestant Meatballs as well as beverages at cash bar.

# How to Play:

On Saturday, March 24, 2012, all contestants will be required to be on site at the Historical Center from 11:00 a.m. to 5:00 p.m. to load-in, participate, and load-out. Each contestant must arrive with their meatballs already prepared and kept in a crock pot or other preapproved heating device to keep warm, to then be sampled by guests and judges. Each contestant is required to bring at least 50 prepared meatballs. Bringing additional meatballs will not give you better chances of winning, but contestants are welcome to bring more than 50. Each contestant will have their own table to distribute and promote their meatball recepie. The Historical Society will provide advertising cards to allow contestants to promote their business or recepie with a name or logo. Arrival and setup of each contestant's station will occur between 11:00 a.m. and 12:00 p.m., with the Challenge beginning at 12:00 p.m. Clean-up and break down of contestant booths can begin to occur after the announcement of the prize winners between 4:00 p.m. and 5:00 p.m.

\*\*NOTE: EACH CONTESTANT (BUSINESS OR INDIVIDUAL) MUST COMPLY WITH THE CITY OF MILWAUKEE HEALTH DEPARTMENT STANDARDS ON FOOD PREPARATION, TEMPORARY FOOD STANDS, AND MUST ACQUIRE A TEMPORARY FOOD DEALER LICENSE FOR THIS EVENT. THE MILWAUKEE COUNTY HISTORICAL SOCIET Y IS NOT RESPONSIBLE FOR EACH CONTESTANT OBTAINING THIS PERMIT. ANY CONTESTANT THAT DOES NOT HAVE A PERMIT WILL NOT BE ALLOWED TO PARTICIPATE. ### **How to Register:**

Register at www.milwaukeehistory.net by filling out a contestant application. The deadline for contestant registration is Wednesday, February 22nd at 4:00 p.m.

### Judge Panel:

The contest's panel of judges will evaluate all of the meatball recipes. The decision of the judging panel is absolute and final. The judging panel reserves the right to refuse an entry if they believe it to be in the best interest of the even or a health concern. Judges will award first, second, and third place prizes. The people's choice award will be determined on a majority ballot vote cast by guests to the Challenge.

**Judging Criteria:** (Taste, Texture, Creativity, Appearance)

Up to 10 points will be awarded for each category. Each contestant will receive a total score. The highest score wins the competition. In the event of a tie, the participants with the same high scores will be put into a random drawing and one winner will be selected as the grand prize winner.

# Other Requirements:

COOKING CONTESTANTS MUST SUPPLY ALL OF THEIR OWN MATERIALS, EQUIPMENT, AND FOOD FOR COOKING/PREPARING.

# **Grand Prize (1st Place)**

Airfare for two (2) to Rome, Italy. Trip includes round trip coach air transportation for two persons (winner & one travel guest) from Milwaukee to an airport in Italy, possibly including stops in connecting flight airports. Hotel accommodations, ground transportation, and any other travel amenities are paid for by the winner. No travel extensions permitted. Winner and travel guest must travel on same itinerary. Trip reservation instructions will be provided at the time of the Grand Prize awarding. Any and all trip fees that are required by the travel company are to be paid by the winner and their guest which are \$\$\$ per person. By participating, all participants and winner(s) grant the Historical Society-permission to use their names, characters, photographs, voices, and likeness in connection with promotion of this contest and waive any claims to royalty, right, or remuneration for such use.

#### Release:

By participating in the Challenge, each participant and winner waives any and all claims of liability against the Historical Society, its directors, employees and agents, the Challenge's sponsors and their respective directors, employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Challenge, or from the use of any prize

#### Taxes:

Any valuation of the prize(s) stated above is based on available information provided to the Historical Society, and the value of any prize awarded to a winner may be reported for tax purposes as required by law.
