Abstract: Henry Gugeler (later Gugler) was born near Stuttgart, Germany, September 16, 1816. He married Fredericke Kasten, and they had four sons: Julius, born 1848; David, born 1851; Robert, born 1855; and Henry, Jr., born 1858 on his parents' first trip to the United States. Julius came to Milwaukee in 1869 and worked first for Seifert & Lawton, Lithographers. Henry moved to Milwaukee in the early 1870's and joined the firm, which soon became Seifert, Gugler & Co. In 1878 the firm changed to H. Gugler & Sons, which included Robert and Henry, Jr., as well as Julius and their father. Henry died in 1880.

Julius and his wife, Bertha Bremer, had four sons and two daughters: Oswald, Ralph, Erich, Hans, Frida, and Gretchen. Julius died in 1919, and his son, Oswald, became President of the company. Oswald died in 1949, and Ralph then became Chairman of the Board. Ralph died in 1956.
