Abstract: The Ogden family were among Milwaukee's earliest settlers. John Ogden (1801-1891) arrived in Milwaukee in 1835. He eventually established a carriage making business in 1849. He sold the company to his sons in 1867, at which time it was renamed G.W. Ogden & Co. George W. Ogden (1844-1930) was the primary operator of the firm until he closed out the business in 1907. Thereafter, he focused his attention on real estate activities until his death in 1930. George's daughter, Marion, was long interested in the social welfare of Milwaukee children. She served on the board of the Milwaukee Boys Club for more than 40 years and also accepted an unpaid appointment as the first probation officer for the juvenile court in 1901. Local history was another of her interests. She was very involved in establishing the Milwaukee County Historical Society in 1935 and wrote several articles for the Society's history magazine. She passed away in 1976 at the age of 101.

Scope and Content: The records consist of correspondence, newspaper clippings, property records, programs and other ephemera.
