Abstract: The position of County Clerk for Milwaukee County was instituted in 1835 by the Michigan territorial governor and continued when Wisconsin Territory was established in 1836. Among the clerk's duties are recording County Board of Supervisors' proceedings, maintaining legislative files, updating existing ordinances, issuing marriage licenses and as an information clearinghouse for county government, maintaining the central files for Milwaukee County reports, records, contracts and corporate documents.

Scope and Content: The collection includes miscellaneous tax records, payroll records and property deeds.

Access and Use: No restrictions

Language: English

Notes: The bulk of the material was donated by the Milwaukee County Clerk, December 2016 and January 2017.
