Abstract: John H. Frank was a lifetime Milwaukee resident and a prominent area businessman. He was the son of Frederick August Frank (1821-1886), who immigrated to the U.S. from Germany in 1850 with four of his brothers. August co-established the Goll and Frank Dry Goods Company, which John later took over after his father's death. John also had many other business interests that included a large investment in the original Federal Rubber Company in Cudahy and various real estate ventures. For the most part, he was very successful until he ran into financial difficulties in 1910, primarily due to problems with the Federal Rubber Company. In addition to his business interests, Frank was the president of the Wisconsin Conservatory of Music.

Scope and Content: The collection consists of personal and business-related correspondence. Much of it is in German, but a large number of letters have been summarized or translated by his family many years after his death. The collection also contains various wills, estates, and deeds as well as those of his father and other family members. There is material related to the Goll and Frank Company as well as the Federal Rubber Company.
