Abstract: The Women's Coalition was formed as an umbrella organization for several feminist groups in the Milwaukee area in the early 1970s.

Scope and Content: The collection contains material on the Coalition's administration, its component organizations and activities as well as extensive files on two of the Coalition's major projects, the Displaced Homemaker Project – designed to help newly widowed or divorced women adjust to the changes in their lives and the Myriad Project – intended to assist women involved with prostitution to become self-sufficient through other means. Also included are issues of *Common Ground*, the coalition's newsletter.
