Abstract: The Public Policy Forum is a Milwaukee-based organization founded in 1910 to promote fiscal responsibility in city and county government. It was originally called the Bureau of Economy and Efficiency, but the name was changed to Milwaukee Citizens Bureau of Municipal Efficiency in 1913 and to the Citizens Bureau of Milwaukee in 1921. The name changed again in 1946 to the Citizens Governmental Research Bureau, which remained until 1987 when it took the present name of the Public Policy Forum.

Scope and Content: The collection includes annual reports, minutes, correspondence, bulletins and published reports.
