**Abstract:** The Woman's Industrial Exchange movement in the 19<sup>th</sup> century was a national network that created economic alternatives for financially vulnerable women in a world that permitted few respectable employment options. Milwaukee's Industrial Exchange opened in 1882 to "teach and promote industries among women and to provide a place for the sale of woman's work." The Exchange closed in 1965.

**Scope and Content:** The collection includes articles of incorporation, correspondence, annual reports, reports from the Board of Directors, historical information, scrapbooks, menus, pamphlets, certificates and miscellaneous ephemera.
