**Abstract:** The Wisconsin Taxpayers Alliance is a nonpartisan, statewide organization formed in 1931 to provide unbiased information that could be used by citizens and government officials to help state and local governments operate more efficiently and effectively. On January 1, 2018, the Alliance merged with the Milwaukee-based Public Policy Forum creating the Wisconsin Policy Forum.

**Scope and Content:** The collection consists of multiple issues of *Wisconsin Taxpayer*, notices of legislative hearings, state and federal income tax guides and miscellaneous booklets/bulletins.
