Abstract: David S. Rose was born in Darlington, WI, in 1856. There, he studied law and practiced with his father. He served as mayor of Darlington (1883-1884) and Lafayette County judge before moving to Milwaukee. He unsuccessfully ran for the city attorney’s office in 1890, but he was elected mayor of Milwaukee in 1898 and served from 1898-1906 and 1908-1910. His administration was tainted by widespread corruption and the promotion of Milwaukee as a “wide-open town” that tolerated prostitution, gambling and late-night saloons. Rose ran again for mayor in 1924 but lost the election to Socialist Dan Hoan. Rose passed away in August 1932.

Scope and Content: The collection consists of newspaper clippings, speeches, reports and other ephemera related to Rose’s career as Milwaukee mayor.
