Abstract: Judge James Augustus Mallory came to Milwaukee in 1850 and began the practice of law. He served as municipal court judge for 29 years. Children of Judge Mallory and Mary J. Bates included Jennie, Lilian and Rollin B. Mallory. Jennie and Lilian were members of the Daughters of the American Revolution. For some years, Lilian conducted a women's page for the *Evening Wisconsin*. Rollin was an attorney who served as city alderman and county public administrator.

Scope and Content: The collection consists of school essays by Rollin, memorabilia, photographs, scrapbooks and genealogical information of the Mallory family gathered in 1900 by Lilian Mallory.
