Abstract: Thomas C. Miller was born on December 18, 1920. By the early 1950s, he was a serviceman with the United Organ Company. In 1956, he established his own organ/piano business, Thomas C. Miller & Associates. Miller acquired the client list and assets of another organ repair business, Roesler-Hunholz, Inc. (incorporated in 1923 and formerly known as the Wm. Schuelke Organ Co.), in 1966 and operated that business as a subsidiary of Miller & Associates.

Scope and Content: The records consist of ledgers, receipts, contracts, correspondence, project notes, tax records, and work diaries. They detail the business operations of Thomas C. Miller & Associates and also Roesler-Hunholz, Inc. Material related specifically to Roesler-Hunholz is filed under that company; all other material is filed under Miller & Associates.
