

**Title:** Milwaukee County Transit System Collection

**Abstract:** The River and Lake Shore Railway Company was the first transportation utility in Milwaukee, beginning its operation May 30, 1860, with two horse-drawn cars on East Water Street. In 1865 it was taken over by the newly incorporated Milwaukee City Railway Co., which was in business until 1890. During this period, other transport companies, running in various areas of the city, were also formed.

There are differences of opinion as to which company operated the first electric cars and on what street, although the sources seem to agree that it was in 1890. That year the Milwaukee City Railway Company was purchased by the Milwaukee Street Railway Co., which proceeded during the next few years to purchase most of the independent companies. By 1894 they had changed all the cars to electric. Bankrupt by 1896, this company was reorganized and deeded to The Milwaukee Electric Railway & Light Co. (TMER&L), which had been incorporated on Jan. 29, 1896. In 1938, TMER&L became the Wisconsin Electric Power Co. (WEP), and The Milwaukee Electric Railway & Transport Co. (TMER&T) was formed as a wholly owned subsidiary of WEP.

A group of investors purchased TMER&T in 1952 and formed the Milwaukee & Suburban Transport Co. (M&STC), which lasted 23 years. In 1975 M&STC was taken over by Milwaukee County, becoming the Milwaukee County Transit System.

**Scope and Content:** The collection consists of annual and special reports, meeting minutes, property and tax documents, clippings, photos and other ephemera. The bulk of the records in this collection are from the Milwaukee & Suburban Transport Co. era, with one box of material from the period prior to that time.

**Access and Use:** No restrictions

**Language:** English

**Notes:** The collection was initially processed by Janet Geronime, March 1989, and added to multiple times thereafter.
