Abstract: Three principal stockholders, Allis Chalmers, the Boston Store Foundation, and Kearney & Trecker, formed the Milwaukee Community Development Corporation (MCDC) in 1952 to develop real estate in Greendale. MCDC developed and sold more than 1/2 of the original 2,300 acres in its first 12 years. In the last months of 1964, MCDC agreed to sell its outstanding stock to the A.L. Grootemaat & Sons, Inc. A business partnership led by James E. Grootemaat formed the Greendale Land Company (GLC) to continue the development of Greendale real estate.

Scope and Content: The collection consists of various records relating to the work of the MCDC and the GLC.
