She served as County Supervisor for the 8th District (encompassing St. Francis, Cudahy, South Milwaukee and parts of Oak Creek) from 2007 to 2016. She served on the Finance & Audit, Transportation & Public Works, Judiciary, and Economic & Community Development committees. On November 24, 2015, she announced she would not seek another term on the board.

Scope and Content: The collection consists of reports, correspondence, memos, news articles, newsletters, meeting minutes and other ephemera detailing Jursik’s work, especially with regard to the county’s transit system and parks.
