Abstract: Dominic Frinzi was a practicing attorney for 60 years and an active figure in Milwaukee's Italian community. He ran for Governor of Wisconsin in 1964 and 1966 and Circuit Court judge in 1968. He passed away in January 2008 at the age of 86.
