Abstract: A group of concerned ladies organized Milwaukee Home for the Friendless in October 1867 with the objective of affording "protection and employment or assistance to needy women and children until other and permanent homes and means of support can be secured for them." The Home was renamed in 1922 to Friendship House.

The Home opened at 346 Cass Street in November of 1867 and took care of 155 destitute women and children temporarily in the first 10 months. By 1869 it moved to 378 Van Buren Street. In 1902 the Wisconsin Legislature appropriated funding (\$3,000) toward a new house. Until 1916 the expenses were underwritten by voluntary contributions and the small daily room and board fee for "working girls." The Home then became one of the charter members of the Milwaukee Centralized Budget of Philanthropies (now the United Fund).

In 1926 the Home was a beneficiary in the estate of Edward T. Harmon, and in 1930 his mother, Mrs. Hester Harmon, an enthusiastic supporter until her death at age 108. These trusts provided income which enabled the Home to meet operating expenses without community fund assistance.

In 1970, in cooperation with the developers of the First Wisconsin complex, the Friendship House exchanged properties and moved to 1029 N. Marshall (from the 378-380 Van Buren location, where the street number was changed to 618 in 1930). The House continues operation.

Scope and Content:

Box 1 contains land ownership documents, bylaws & constitutions, incorporation records, lease/financial agreements, general historical information, newsletters, newspaper clippings, membership lists, annual reports, tax records and estate records of some prominent Milwaukee residents.

Box 2 contains Annual Audit reports provided by the then current accounting firm overseeing the financial matters of the House include banking and investment status. Matrons' Journals give an account of those that stayed at Friendship house and usually some discussion of their status. The Book of Cases provides notes on legal cases involving some of those that stayed at the House.

Secretary's Books, Recording Secretary's notes, and Minutes Books in Box 3 include minutes from Board and Member meetings, committee annual reports, President's annual report, and items presented at Board meetings.

Box 4 contains several oversized bound volumes included in the collection: Leather-bound Matron's Journals; Secretary's Books from several years; the Register, Home For The Friendless (another form of a Matron's Journal); and early financial records for the House.

Scrap Books -5 oversized scrap books located in rolling cabinets. 2 scrap books photocopied and disassembled placed in Box 1. Miscellaneous photographs placed in Box 1.
