Historical Note: H. Weden and Sons was an established Milwaukee painting contractor firm that went out of business in November 1981. The earliest reference to the firm's namesake, Henry Weden, is found in the 1877 City Directory. The firm was incorporated in 1906. Through the years the firm contracted for the painting of many prominent Milwaukee buildings including City Hall, the Auditorium, and the Blatz Brewery.

Administrative Note: The collection was reprocessed on September 27, 2011 by Jenny Stevenson. Due to conservation issues the items in box 2 and 3 were dismantled from the original bindings. Original order was maintained within the folders.
