Abstract: The contents of this collection came from Judge Marvin C. Holz. Holz worked with Judge Elmer W. Roller who signed the decision declaring that the Milwaukee Braves must return to Milwaukee or the National League must guarantee the city would get a new franchise. This was part of an antitrust suit brought against Milwaukee Braves et al. by the state of Wisconsin.

Abstract: The collection contains Circuit Court records of the Milwaukee County transcripts and other legal documents pertaining to the antitrust suit brought against the Milwaukee Braves by the state of Wisconsin.
