Abstract: Founded in 1935, the Milwaukee County Genealogical Society is an organization with the objectives of collecting, exchanging, and preserving genealogical materials; informing the general public about genealogy; and purchasing books of genealogical value to be donated to public libraries in the Milwaukee area. The Milwaukee County Genealogical Society Milwaukee County Court Records consists of floppy disks presumably containing information about (including the docket index for) Milwaukee County civil court records. The disks have not been read or reviewed. The disk descriptions listed in the inventory below are solely based on the labeling of the disks themselves, including what appear to be six-digit court case numbers as well as computer file names and occasional notes. The collection also includes printed documents, mostly printouts of files on the floppy disks.
