**Abstract:** John Pritzlaff and A.F. Suelflohn established a hardware store in 1850. It grew steadily, enabling Pritzlaff to buy out his partner in 1853. As the business prospered, Pritzlaff shifted his attention to the wholesale side of the business, and in 1875, he built a warehouse on Plankinton Ave. that supplied the inventory for local retailers. In 1884, the business was incorporated as the John Pritzlaff Hardware Company, and three generations of the family led the company through two world wars and the Great Depression. During the 1950s, however, competition from national hardware chains forced the company to close its doors in 1958.

**Scope and Content:** The collection is organized into a small manuscript collection, oversize items and ledgers. The small manuscript collection contains anniversary materials, clippings and other promotional materials. The oversize items include letters and other personal materials relating to John Pritzlaff. The ledgers date from 1881-1954 and cover a variety of materials relating to the company.
