Notes: The Inventory of Court Minute Books and Related Volumes July 1990) Minute Books also come under other titles – "Judge's Record Book," "Journal" and "Record." Without closer examination, the distinction between types of record books is unclear. However, the volumes list the cases for a given session of the court (entered chronologically), sworn statements, objections, adjournments, verdicts and lists of jurors. The minute books listed in the first section of the inventory appear to be all Circuit Court civil cases. It is unclear if they are differentiated between the Equity, Chancery or Law-type cases. There is numerous overlapping in the minute book inventory. This is probably due to different types of minute books from the court that cover the same period – that is, some may be the Judge's Record Book while another covering the same period may be the court's Journal.
