Historical Note: William McGowan was born on March 7, 1907, in County Down, Ireland. Shortly thereafter, his family relocated to Janesville, Wisconsin. He studied law at the University of Wisconsin and, from 1932 to 1942, was associated with the Milwaukee law firm of Lines, Spooner and Quarles. In 1942, he joined the legal staff of Allis-Chalmers. He was named director of the Employee and Community Relations Division in 1955 and served in that capacity until 1968, when he was appointed staff assistant to the Chairman of Allis-Chalmers. During the 1960s, he was involved in efforts to facilitate the hiring of minorities. He was director of the Milwaukee Urban League from 1960 to 1969, secretary to the Milwaukee Voluntary Equal Employment Opportunity Council, a member of the City of Milwaukee Commission on Community Relations, and a member of the Plans for Progress Advisory Council in Washington, D.C. He retired from Allis-Chalmers in 1972 but continued serving as a Washington liaison until 1979.

**Scope and Content:** The records consist of correspondence, clippings, speeches, minutes, pamphlets, various publications, and photographs. They primarily describe McGowan's work with Allis-Chalmers, but also includes his involvement with several of the above-named organizations as well as some personal material. The collection includes information pertaining to labor-management relations at Allis-Chalmers, communist infiltration of the UAW Local, and minority hiring by Milwaukee-area businesses. The files are arranged alphabetically by subject.
