Historical Note: The Board of Election Commissioners of Milwaukee County was created in 1915 by an act of the Legislature. It consists of three members, each chosen from lists of at least three names each, selected and approved by the county committee of the two political parties receiving the most votes for governor in the last election. The County Executive selects from the lists two persons from the majority party and one person from the next highest party. This office is an agency of the county government and its functions are to supervise all elections vested by the state and County Board of Supervisors.

Scope and Content: This collection contains annual reports, maps, election statistics, newspaper clippings, meeting minutes, campaign finance reports and other ephemera. The material pertaining to the 1992 Milwaukee County redistricting illustrate the political/racial factors that influenced the effort.

Administrative Note: The collection was initially processed on March 12, 1997 by Steve Daily. Additional material was added several times thereafter.
