Abstract: Penny Podell was born in St. Louis, MO, on May 26, 1946. She came to Milwaukee in 1957 and attended the University of Wisconsin-Madison and University of Wisconsin-Milwaukee. She served as a Shorewood Trustee from 1975-1980 when she was elected to represent the 3rd District on the County Board of Supervisors. She served on the county board for 22 years. She was defeated in a 2002 recall that stemmed from voter anger over the county pension scandal.

Scope and Content: The collection consists of meeting minutes, correspondence, reports, memos, newspaper clippings, newsletters and other ephemera detailing Podell's work as a County Supervisor, especially her work on various committees and task forces pertaining to the environment/pesticide use as well as Milwaukee parks and lakefront.
