Abstract: The Northwestern National Insurance Company (NNIC) was a pioneer Milwaukee insurance company organized in 1869. Until 1930, NNIC's business was limited to fire and allied forms of insurance, but that year it entered casualty lines of business through its subsidiary, Northwestern National Casualty Company.

In February 1968, NNIC's board of directors and management organized NN Corporation (NNC) under Delaware statutes as a holding company with general business purposes. In July 1986, an exchange offer was made to NNIC stock for NNC stock on a one-for-one basis. NNC then merged with and into Armco Financial Services Corporation effective December 1, 1980. NNIC ceased writing new individual health policies in February 1975. Group and association health insurance business was terminated in April 1977. NNIC went into run-off on January 1, 1986 with the exception for mandatory writings of their guaranteed renewable accident and health policies. Thereafter, the company underwent several mergers, rehabilitation events and restructuring. In 2017, Sandell Holdings Ltd. acquired controlling interest in NNIC and liquidated the company assets in May 2019.

Scope and Content: The collection consists of ledgers, cash books, minutes of board meetings, statistical books, photographs and other ephemera detailing the company's history. Also included is material pertaining to the Ensign Insurance Company and Dominion Insurance Company, Canadian affiliates of NNIC, as well as the Northwestern National Casualty Company, and the Northwestern Underwriters Agency, a division of NNIC.
