Historical Note: Ph. Orth Co. was founded in 1882 in Sullivan, Wisconsin by Philip Orth. The company milled and traded flour, feed and grains. After the company moved to Milwaukee, milling was discontinued. In time the company sold a complete line of bakery supplies. Philip Orth's son, Philip V. Orth, joined the firm in 1911 and grandson, Philip W. Orth, joined the company after World War II. The bulk of the collection consists of company records with some files on Philip and Martha Orth and some files on Philip V. and Irene Orth.

Scope and Content: The collection consists of business ledgers, correspondence, tax documents, wills and other ephemera documenting the company's operations.

Administrative Note: The collection was donated by Philip W. Orth. It was processed on August 27, 1996 by Janet K. Geronime.
