Scope and Content: Emmet L. Richardson was a prominent Milwaukee lawyer. He was born in Evansville, Indiana, in 1870 and attended the University of Indiana and Stanford University and graduated from Harvard Law School in 1897. He came to Milwaukee in 1898 and established a successful law practice, eventually becoming senior partner in the law firm of Upham, Black, Russell & Richardson. Emmet served on the Milwaukee Board of School Directors, was first president of the Milwaukee Art Commission and was a trustee of the Public Library and Public Museum. He also was an avid lawn bowler. He met Harriet J. Fyffe at Stanford and they married in 1896. Harriet – a cousin of Illinois politician Adlai Stevenson – was born in Normal, Illinois, in 1872. She was a civic leader in her own right, serving with the Milwaukee division of the American Association of University Women, the Woman's Club of Wisconsin, the Legal Aid Society and University Settlement. Harriet passed away in 1952 and Emmet in 1960.

The collection largely consists of correspondence between Emmet and Harriet during their courtship. The remaining correspondence primarily discusses various family matters. Harriet's diaries offer glimpses into Milwaukee life during World War I, the Great Depression and World War II. The photos depict Harriet and Emmet, Emmet's lawn bowling activities, and interior/exterior photos of their home at 2734 E. Bradford Avenue in Milwaukee.
