**Historical Note:** Timothy Appleton Chapman came to Milwaukee in 1857 and with the assistance of the C. F. Hovey and Company of Boston, established a business on East Water Street under the name of Hasset and Chapman.

By 1865, Chapman was sole owner of the business. His then erected a \$200,000 store at East Wisconsin and Milwaukee streets that was completed in 1872. At the time, it was the largest retail dry goods store in the Northwest until a fire on the night of October 23, 1884 destroyed it. Chapman decided to rebuild immediately and within six months had constructed a new store at the same location. T. A. Chapman remained in control of the store until his death in 1892. Since then, the ownership and management stayed within the family and descendants of the founder. Some of the family members included in the material are George P. Miller, William M. and Norman M. Chester, George W. Johns, and Verne R. Read.

The company went through many changes over the years, including the building of two branch stores, and the modernization and improvement of its downtown store through the building of a parking structure.
