Historical Note: Charles Wilkins Norris was born in Milwaukee on July 15, 1849, and died on October 12, 1916. He spent his entire life in this city and worked from the time he was eighteen at the G. D. Norris Company, ship chandlers, which his father, Greenleaf, started until he retired in 1883 to follow other pursuits. In addition to his business interests, Charles supported various humanitarian causes such as the Wisconsin Humane Society, Legal Aid Society, and Civil Service Reform Club. Charles married Fannie Wells in 1880.

Fannie Wells Norris was the daughter of Daniel Wells Jr., and was born on January 1, 1852 and attended Seventh Ward School which is where she met her husband. Fannie was respected for her many contributions to charitable causes with one of the main ones being her support and interest in the Norris Farm for boys. This was run by her son, Daniel (Niel) Wells Norris as a home for boys that needed help and a place to live. Fannie died on April 27, 1937.

Scope and Content: The bulk of this collection is made up of the correspondence and financial papers of Charles W. Norris and his wife, Fannie Wells Norris. Other family members are represented in various pieces of correspondence, documents, and clippings. They include Greenleaf Dudley Norris, Alice Brooks Norris, Charlotte Norris, Daniel (Niel) Wells Norris, and others. Some clippings, genealogy, and scrapbooks are here as well as family photos.
