**Scope and Content:** Milwaukee Aerie No. 137, Fraternal Order of Eagles was organized in April 1901. Its members moved from one meeting house to another before moving into a new clubhouse at 2401 West Wisconsin Ave. in 1927. The club's purpose was to establish an "order of good things." Its members took part in numerous charitable campaigns and also spearheaded drives for social legislation, such as old age pensions and social security. In the 1960s, however, the club came under fire for its "whites only" membership policy. The records consist of newsletters, magazines, convention programs, membership applications, death claims, financial records, clippings, correspondence, and reports.
