

**Title:** Milwaukee Circuit Court Judge Robert Curley

**Abstract:** Judge Robert M. Curley (1922-2001) served in the United States Navy from 1942 through 1946 and remained in the United States Navy Reserve until 1960. He attended the University of Notre Dame and received his law degree from Marquette Law School. Curley was a Wisconsin State Assemblyman from 1958 to 1960 when he was appointed to the Wisconsin Circuit Court in Milwaukee County. He served as Chief Judge four times over the course of his career. He retired from his position on the Circuit Court in 1983. In 1978, his daughter, Patricia S. Curley, was also appointed to the Circuit Court bench.

**Scope and Content:** The collection consists of material relating to the case work of Robert M. Curley as a Circuit Court judge. There are lists of cases relating to their scheduling and which judge presides over them. Other material relates to the statistical and financial reporting of cases. A majority of the material is dockets written by Curley, with attached case documents providing expanding knowledge. Most of the cases appear to be regarding divorce or other family proceedings.
